**V. New or Unfinished Business**

**A. Public Hearing: Hannaford Woods Land Acquisition Conversion**

Public Hearing was opened at 8:35 am. Director Culp introduced the Hannaford Woods Land Acquisition Conversion. He stated that the Hannaford Woods-Nickels Farm consists of 402 acres. There is 53.45 acres being acquired from Waubensee Community College in exchange for the 8 acres that were inside a grant border. This property is adjacent to the Waubensee Community College and Bliss Woods Forest Preserve.

**DISCUSSION:** *Commissioner Smith asked what kind of ecosystem was on the property. Director Haberthur explained that there are oaks but nothing of significance, the District has plans for restoration projects. President Kenyon asked how the property was going to be used by the college. Director Culp answered that the land will continue to be open space as they are ball fields for the college. Blackberry Creek runs through the property and there are 50' buffers of protected open space on either side of the creek. Commissioner Gillam asked if there was a maintenance agreement for the fields. Director Culp declared that the agreement spells out the prohibiting of chemicals that would harm other habitats.*
